President's Message

When I was selected President of PAST in June, I was deeply honored. Also fortunate, since the Board shares my passion and determination to preserve historic buildings and neighborhoods in Palo Alto and Stanford. While the Board and PAST members may agree that these residences and commercial buildings add greatly to the character and definition of our city, many others do not.

One of our goals for this year, in addition to hosting the Holiday House Tour and the Centennial Awards Ceremony, is to educate ourselves and the public about the benefits of preservation. Last May, we reinstated walking tours in Professorville, Downtown and along Homer Avenue. These tours were well received and we plan to repeat them in the Fall. Hopefully, by 2013, we'll include other neighborhoods.

Another goal, harder to achieve, is our plan to be proactive instead of reactive. How could PAST and its supporters have prevented the destruction of two houses eligible for the California Register of Historic Resources: the Birge Clark at 1721 Webster and the Charles Sumner at 490 Santa Rita. Or, have prevented the demolition of the National Regis-

ter home of Juana Briones? What is the best way to ensure that Julia Morgan's Community Center (MacArthur Park) is preserved and retains its status as a National Register landmark? We plan to meet with City officials to better understand the labyrinthine process by which significant structures can be preserved. Ultimately, we hope to establish a means to inform PAST, concerned citizens, realtors and home buyers of the status and value of historic buildings.

I would like to thank outgoing Board President, Scott Smithwick and long-time Board members Grace Hinton, Jinny Henke and Natalie Loukianoff for their outstanding leadership and commitment. Their past efforts make easier the work of our new Board members – Ellie Mansfield, Hayley Stevens and Fran Wagstaff.

2012–2013 promises to be challenging but fun — especially, if Sisyphus is your mentor! I hope that you'll come to our events and that you'll feel free to contact me with your suggestions and offers of help. ☼

Preservation Month Recap

Mayor Yiaweh Yeh got the month of May off to an auspicious start by issuing a Proclamation declaring May as Preservation Month in Palo Alto. This was followed on three consecutive Saturdays by sold-out Walking Tours of Homer Avenue by Margaret Feuer, Downtown Palo Alto by Suzanne Mantell and Professorville by Gail Woolley. Thanks also to Brian George for taping these events.

Over 100 people attended the 17th Annual Awarding of Centennial plaques held on May 20 at the Palo Alto Woman's Club. Twelve houses, built in 1912, received commemorative brass plaques as well as 13 houses built in prior years. Thanks to Janet Peacock for all her research. In addition, Lifetime Achievement Awards were given to Bob French, Steve Staiger and Tom and Ellen Wyman for their outstanding preservation work in Education,

History and the Palo Alto Libraries. Finally, five Preservation Awards were presented to owners along with the architects and contractors who restored or adapted historic buildings.

The feature presentation of this gala event was a talk by author, Jacquie Proctor on "Bay Area Beauty—The Artistry of Harold G. Stoner, Architect." Little known, but prolific, Stoner was the architect of San Francisco's Sutro Baths as well as several houses in Palo Alto.

For the rehabilitation of and addition to a historic home located in the Professorville Historic District. The rehabilitation removed multiple later additions to carefully restore the building to its circa 1900 appearance by preserving the historic windows and exterior details, replicating the balustrade on the restored porch, and creating a new addition that appears to seamlessly blend with the historic home.

For the adaptive use of the former home of the Sea Scouts, a Category 1 historic structure on the City of Palo Alto's historic inventory. This adaptive use carefully preserves the Birge Clark streamline moderne details, such as the porthole windows and liner-like appearance, while creating new office space, interior meeting spaces, and integrating the building into the natural coastline of the marsh.

For the rehabilitation of 1128 Webster, a Category 4 home on the City of Palo Alto's historic inventory. The rehabilitation preserved the 1894 vernacular details of the building, such as the shiplap siding and turned porch columns, while providing the owners with a modern home.

Meet our New Board Members

FRAN WAGSTAFF

Fran Wagstaff is a thirty year resident of Palo Alto and lives in Midtown. She was the former President of Mid Peninsula Housing Corporation (MPHC) which she led for 26 years. This non-profit organization is one of the largest providers of affordable housing in the country and has developed and owns a portfolio of more than 6,000 units of rental housing in eight Bay Area counties for low income families, seniors and the disabled.

Fran's interest in historic preservation stems in part from her development experience at MPHC where she encountered a number of historic dwellings on potential building sites. Rather than razing these buildings, they were saved and incorporated into multifamily housing, often informing the architecture of the new housing and thereby adding charm and warmth to new communities. The most recent of these preservation efforts, De Vries Place in Milpitas, preserved one of only three remaining historic homes in the city, a large prairie style house which was the home of the first doctor in the city. The first floor of the house now serves as a community building for the multifamily senior housing which surrounds it while the second floor houses 3 residential units. Among many awards, this project received an international Urban Land institute award for excellence in 2009. Fran now brings her expertise and understanding of the value of historic preservation to the Board of PAST.

HAYLEY STEVENS

Hayley Stevens has been a resident of Palo Alto all her life. Born at Stanford Hospital, she attended local schools graduating from Paly. She was introduced to the preservation world by her parents who restored two Palo Alto houses: 947 Waverley St. (1904) and the Polly and Jake house at 730 Bryant St. (1902).

Graduating from Mount Holyoke College, with majors in Art History and Religion, Hayley went on to study Art in Florence, Italy with Syracuse University, and Architectural Design at the University of California, Berkeley. A homebody at heart, she returned to the Peninsula after college, where she worked for Architectural Resources Group in their conservation division and for the Fine Arts Museums of San Francisco in the European Paintings department. She has also worked for local architects FGY and is currently employed by Phoenix Systems Smart Home Technologies. Hayley is also an avid equestrian and has volunteered as a head coach for Palo Alto Girls Softball. We look forward to Hayley's breadth of experience and youthful enthusiasm.

ELLIE MANSFIELD

Ellie Mansfield has lived in Palo Alto since 1954 except for two years spent in Germany with her husband while he was in the military. After graduating from Stanford University in 1958, she attended and graduated from Stanford Law School in 1962.

For 30 years, Ellie worked for Sempervirens Fund, a Santa Cruz Mountains land conservancy. In her retirement, she is on the Board of Directors of Avenidas in Palo Alto and the Alumnae Board of Cap and Gown at Stanford; she is also a member of the Woman's Club of Palo Alto. In her "spare" time, Ellie sings with a small group of women performing at retirement and convalescent homes throughout the year.

Ellie and her husband, Dick have three children and four grandchildren. They live in a much remodeled Birge Clark home. PAST welcomes Ellie Mansfield because of her work and volunteer experience but, more importantly because she brings pleasure to all who work with her.

The Professorville Design Guidelines Committee (PDGC)



The PDGC was formed in reaction to the demolition of 405 Lincoln Avenue, the former home of Fr. Dan Duryea and a contributing building in the Professorville Historic District. This committee is working to identify all properties in Professorville: the individually historic properties, the contributors to the National Register Historic District and also the non-contributing structures within the district. The committee's work is intended to produce a set of guidelines which will be used in conjunction with the City of Palo Alto's existing Individual Review Guidelines. Currently, PDGC is awaiting Staff comments before presenting the proposed guidelines to the Historic Resources Board and to the public for comment. All working meetings are open to the public. Public Projects Advocacy Committee

Though I'm officially off the PAST Board, I am forming a new off-board committee. This committee seeks active, enthusiastic persons with both specific "portfolio" skills (architecture, landscape architecture, construction, preservation, fundraising, etc.) and the ability to work well with others. We want to create an effective, balanced group that can augment our grass roots organization by tackling actual preservation projects in Palo Alto. Our strategy will be to focus on small-project preservation needs in the public/semi-public sphere, publicize projects, work proactively rather than reactively with owners, raise funds to match or cover construction projects, and affect the profile of PAST in a positive fashion.

The committee will present the Board with a proposed project, outlining the scope of work. If the Board agrees to the project, then the committee will put together a complete project proposal, with plans, outline specifications, es-

timate of construction costs, and schedule. In addition, we will present a proposal of cost burden or cost sharing to the Board, as well as fund-raising plans and goals.
